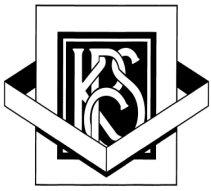

Available openings	Kentwood Public Schools will be accepting 5 students Kindergarten through 9 th grade
Application period	May 17 – May 31, 2013
Selection process	<ul style="list-style-type: none">➤ If the district receives more than 5 applications, a lottery/random draw will be conducted.➤ Students not accepted in the lottery will be placed on a waiting list in the event an opening should occur.➤ Siblings of students previously accepted under the Schools of Choice Program will be assigned to open spots before a lottery/random draw begins.
Notification process	You will be notified by mail no later than <u>June 15, 2013</u> if your child/children are selected or not selected.
Key program points	<ul style="list-style-type: none">➤ You do not need to reapply every year. After you are accepted, you will be allowed continuous enrollment in that district until graduation or until you withdraw from that district at which time you may return to your resident district. If you withdraw and still live outside of Kentwood Public Schools District and later would like to re-enroll, you must reapply through Schools of Choice.➤ Accepted students must agree to comply with choice district policies.➤ Transportation is NOT provided for Schools of Choice students. Parents must provide their own transportation to and from school for children accepted for enrollment through 105C Schools of Choice Plan.➤ Special Education students wishing to enroll under 105C Schools of Choice Plan for whom a written cooperative agreement regarding costs cannot be obtained with their district of residence will be refused Schools of Choice.➤ Enrollment may also be denied to students who have been suspended, expelled, or convicted of a felony.
