Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2022-23 educational progress for Valleywood Middle School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have any questions about the AER, please contact the Principal, Mr. Justin Mathes for assistance.

For the 2023-24 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2022-23. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given. Our school has not been given one of these labels.

State law requires that we also report additional information.

Valleywood has implemented the following Reading strategies and interventions for students who perform below grade level in reading: READ 180 program, Systems 44, Lindamood-Bell, , and One-To-One intervention. Each student below grade level has a combined two hours of ELA instruction, allowing for deeper and more rigorous instruction. In order to support students who are below proficiency in Math, Valleywood provides a Math Support class in addition to one hour of math instruction. Each grade level team has access to an English Learner Intervention Specialists that are available to assist EL students with a focus on homework, study-skills, make-up work, re-teaching, parent communication, and test-taking/make ups. In addition to supporting our students, we have created a professional learning community within our math department including a dedicated math instructional coach. Teachers are attending professional development training to focus on core instruction and assessment.

We appreciate the continued support of parents, staff and our community in this effort. This school year, we will continue a math support program based on extensive research for students who are performing below grade-level. Valleywood will continue to expand its MTSS structure in academics and behavior to ensure a rigorous and supportive program for all students. Valleywood is also using our i-Ready data to identify individual needs in both math and reading. Students then use Falcon Flex time to focus on their i-Ready MyPath determined by the diagnostic test administered three times per year.

ASSIGNING PUPILS TO THE SCHOOL

Students in Kentwood Public School District are assigned to individual school buildings based on the grade level they attend and the geographic area in which they live. School boundaries were developed with community involvement and can be viewed at the Kentwood Public Schools Administration Building at 5820 Eastern Ave. S.E.

SCHOOL IMPROVEMENT PLAN

Crestwood Middle School has an approved School Improvement Plan submitted to the State in which stakeholders have outlined goals and objectives that address student academic needs. Looking at a variety of data that measure student academic progress, we identified areas for improvement and research-based strategies to address these needs.

CORE CURRICULUM

Process: Kentwood Public Schools has aligned curriculum in all content areas with the Michigan Curriculum Framework and the Michigan Merit Curriculum.

Benchmarks can be found on the Michigan Department of Education website: http://www.michigan.gov/mde. Our assessments and report cards are also aligned with the curriculum. Classroom instruction is congruent with the curriculum expectations and is monitored constantly by building principals and academic support personnel.

Alignment: Each grade level on the elementary level and each content area at the secondary levels meet regularly to study curriculum issues and to ensure that all students have common, equitable curricular experiences. A gap analysis is conducted annually with the M-STEP testing information and the curriculum is examined for areas of strength and weakness. After this audit, necessary adjustments are made.

"Excellence and Equity in Education" is the motto of Kentwood Public Schools. Common assessments with common scoring rubrics and common curriculum materials help us work toward our goal of equity. In addition, principals and other evaluators have common instructional expectations that are used to guide teacher evaluation. Professional development, study groups, and constant communication between regular education, special education, and gifted programs also facilitate this process. We are committed to ALL of our students having multiple opportunities to learn and be successful in the core curriculum.
