Dear Parents, Guardians and Students:

As you may have seen this evening, the Michigan Department of Health and Human Services (MDHHS) has issued a new mandate for the state of Michigan to help slow the COVID 19 epidemic. Included in this mandate is direction for all high schools to suspend in person learning until at least December 8. This would include East Kentwood High School 9-12 and Crossroads Alternative High School. Please note, Crossroads Alternative High School will begin remote learning on Tuesday, November 17.

When learning of this new mandate, our Kentwood administration immediately began conversations with the Kent County Health Department (KCHD) in regards to in person learning for our Pre-K through 8th grade students. They have made the recommendation to move all of our Early Childhood, Kindergarten through 8th grade and after school ARCH Programs in Kentwood Public Schools to 100% remote/virtual learning starting Tuesday, November 17 through at least Tuesday, December 1. This recommendation is based on the number of positive cases in the district, the number of staff and students in quarantine and the increasing difficulty for our schools to staff in person classrooms and provide bus transportation. All KPS students currently in remote learning will continue with the same learning procedures as prior to the new mandate. Just a reminder, all GSRP students will receive their communication from the KISD.

This is a very hard decision and one we do not take lightly. We know this will place many hardships on our students, families and staff but we must comply with this recommendation to keep all of us safe for the future. Please know that our school district will be there to support you with food, educational services, supplies and mental health services. You are not alone in this fight and we are here to help get through this, like we always do, as a Kentwood family.

You will receive will receive further communications tonight or tomorrow regarding the following topics:

- Bus transportation schedule for Monday, November 16. We are short quite a few bus drivers due to quarantine and this will affect the schedule tomorrow.
- Email communication from your child's Principal regarding remote learning
- Food distribution schedule during remote learning
- The Athletic Department will communicate changes related to athletic practices and competitions

As a district, our goal is to provide our students and families with an in person learning option as soon as it is safe. It is important for us to continue to work together, whether in school or in the community, to keep each other safe and healthy. Together we will get through this.
